Applications should be submitted by registered post or by hand. Applications should be sent by registered post to be received at or before **2.00 p.m.** on **26th December 2025** addressed to Senior Assistant Bursar, Buddhist and Pali University of Sri Lanka, No. 37, Moragahahena Road, Pitipana, Homagama and "Registration of Suppliers - **2026**" should be marked at the top left corner of the envelope. Applications received after **2.00 p.m.** on **26th December 2025** will be rejected.
